Buy back plan periodical report.

Milan, 8 August 2008 - As an updating of the performance of the buy back plan, authorized by the Shareholders' Meeting as of 28 January 2008 and started by the Board of Directors on 19 March 2008, Cairo Communication notices that in the period starting from 4 August 2008 and until 7 August 2008 it has been purchased 4,999 ordinary shares of Cairo Communication S.p.A. (corresponding to 0.006 % of the share capital), at an average unit price of 2.3771 Euros and for a total amount of 11,883.22 Euros.

As of 7 August 2008, Cairo Communication owns 736,404 own shares, corresponding to 0.940 % of the share capital.
