Buy back plan periodical report.

Milano, 18 April 2008 – As an updating of the performance of the buy back plan, authorized by the Shareholders' Meeting as of 28 January 2008 and started by the Board of Directors on 19 March 2008, Cairo Communication notices that in the period starting from 5 April 2008 and until 18 April 2008 it has been purchased 15,375 ordinary shares of Cairo Communication S.p.A. (corresponding to 0.020 % of the share capital), at an average unit price of 2.7246 Euros and for a total amount of 41,891.27 Euros.

As of today Cairo Communication owns 528,955 own shares, corresponding to 0.675 % of the share capital.
