Buy back plan periodical report.

Milano, 4 April 2008 – As an updating of the performance of the buy back plan, authorized by the Shareholders' Meeting as of 28 January 2008 and started by the Board of Directors on 19 March 2008, Cairo Communication notices that in the period starting from 29 March 2008 and until 4 April 2008 it has been purchased 3,150 ordinary shares of Cairo Communication S.p.A. (corresponding to 0.004 % of the share capital), at an average unit price of 2.751 Euros and for a total amount of 8,665.97 Euros.

As of today Cairo Communication owns 513,580 own shares, corresponding to 0.656 % of the share capital.
